- Determine smoking rates among gamblers and compare to current smoking rates in Washoe County
- Use data to build support for ordinances to prohibit smoking in casinos and bars




Total number of gamblers observed smoking Multiplied by 3 to determine total number of gamblers who were smoking

Observed Smokers






Number gamblers who were smoking

- All casinos excluding Dotty's/Grampy's




Number of Smokers, All locations

National, State, County Smoking Rates

- 2006 U.S. Smoking Rate 20.9 % (2006 ATS)
 - Nevada Smoking Rate 23.1% (2017 BRFSS)
 - Washoe County Smoking Rate 18.7% (ATS 2006)
 - > Study findings: 20.9% (+/- 1.2%)
- Current U.S. Smoking Rate 14 % (CDC)
 - Nevada Smoking Rate 17.6 % (2017 BRFSS)
 - Washoe County Smoking Rate 14.6% (2017 BRFSS)
 - > Study findings: 19.25% (+/- 1.19%)

Study Conclusion

- The percent of gamblers who smoke (19.25%) is higher than the current average smoking rate in Washoe County (14.6%) and in the US (14.0%).
- While smoking rates among the general population have dropped between 2006 and 2019, study findings show that smoking rates among gamblers has not changed significantly.

Alliance Event Survey

- Networking Event
- 35 people completed survey
- 33 question survey



Survey Demographics

- Male- 37.1% and Female- 62.9%
- Education- College Graduate 42.9%, and Graduate/Professional degree 31.4%
- Political view- Somewhat conservative 34.3%, Somewhat liberal 14.3%, Moderate 22%, Very conservative 8.6%, and Very liberal 20%

Survey Questions

- Preference and frequency of visits to area casinos
- Supportive of employees and casino patrons
- Frequency change in visits
- Impressions and/or beliefs about ordinances
- Knowledge of SHS exposure
- Favor or oppose SF WP

Survey Results

- Recent visit to casino within past 3 months- 77%
- Reason for visit
 - Majority for restaurants, bars, spas, shows, meeting facilities
 - Smaller percentage was for gaming
- Favor an ordinance to prohibit smoking in casinos- 68.6%
- Knowledge about health impacts of exposure to secondhand smoke- 85.7%
- Belief that SF would positively impact casino revenues- 57%
- Belief that casino employees/patrons deserve to breathe clean air- 77.1%

Alliance Survey Conclusion

- Respondents did not report frequenting casinos for gaming reasons
- Respondents believe that casino employees and casino patrons deserve to breathe clean air, and they would frequent casinos more often if the casinos were smoke free
